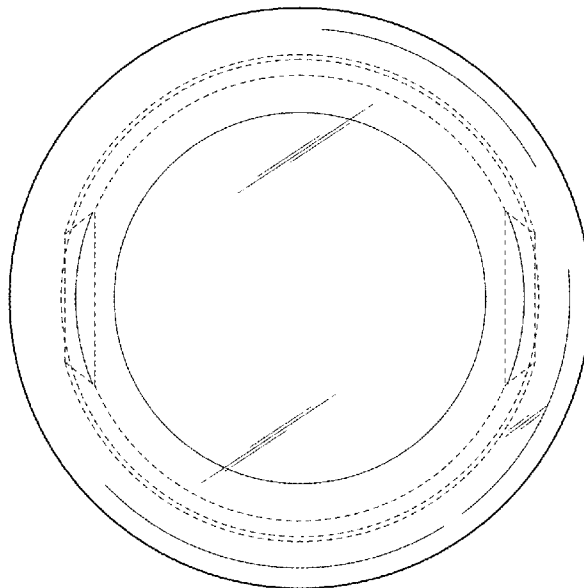
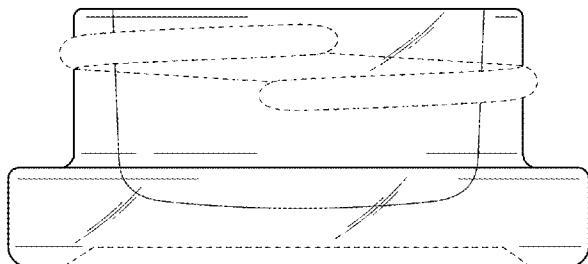
CLAIM

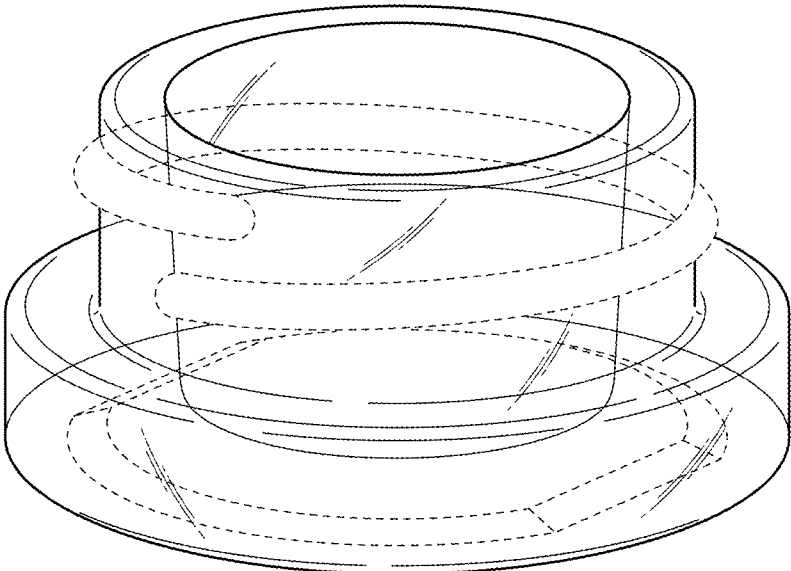

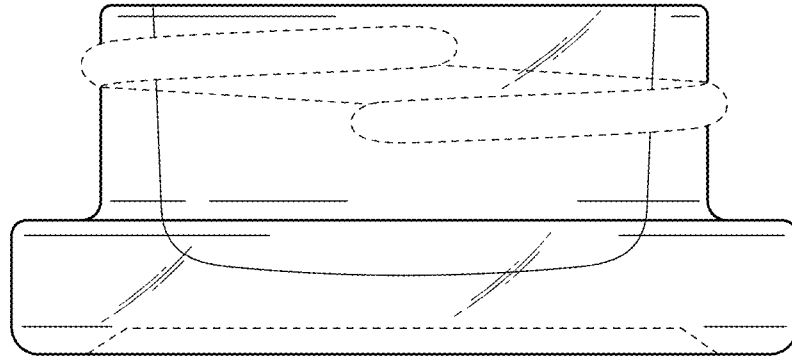

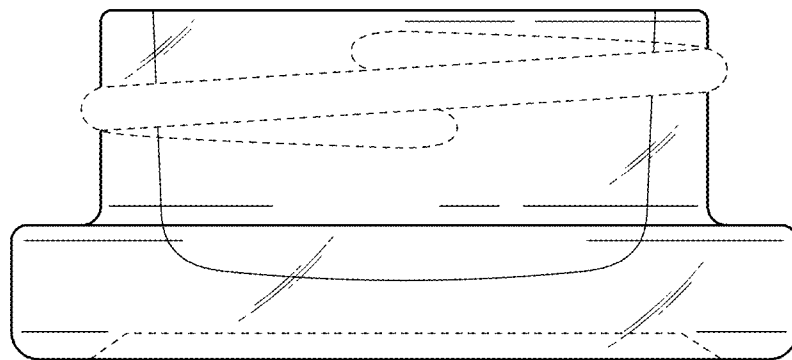

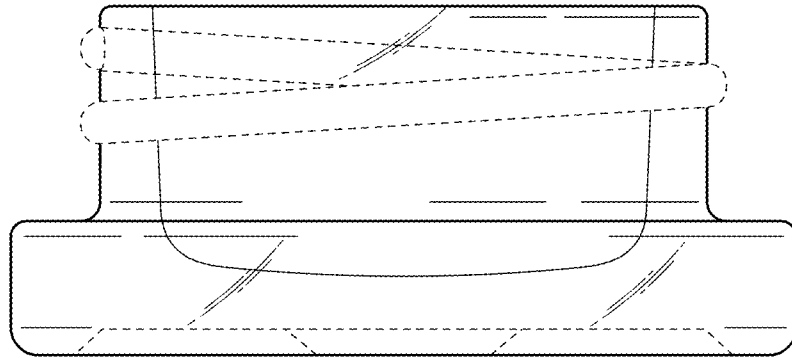

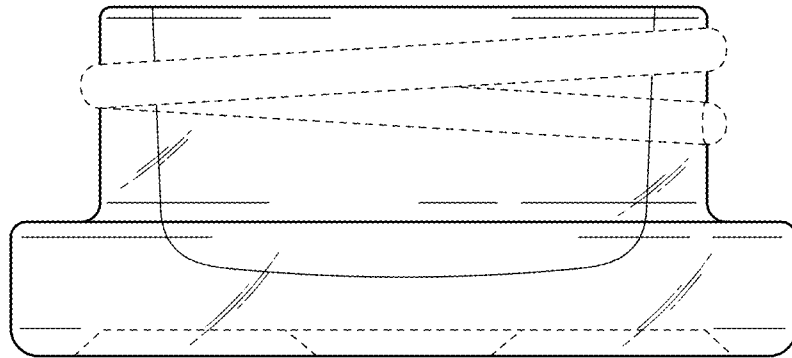

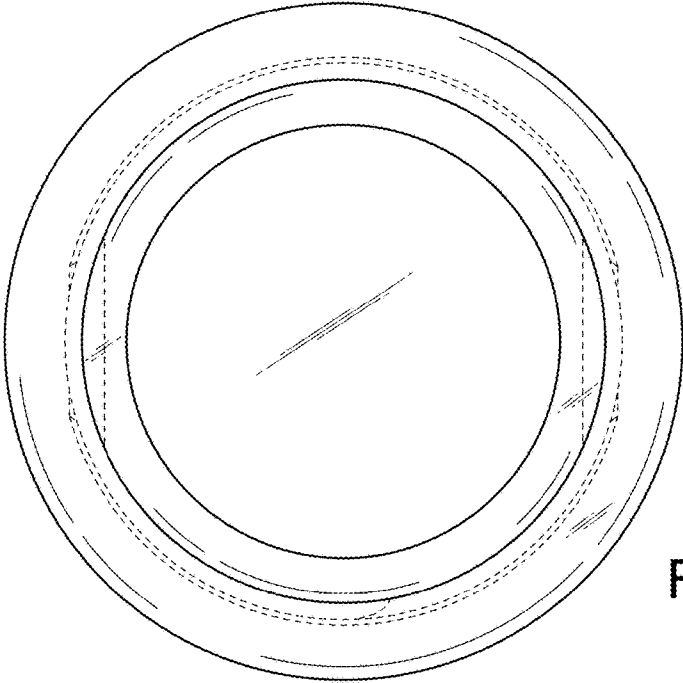

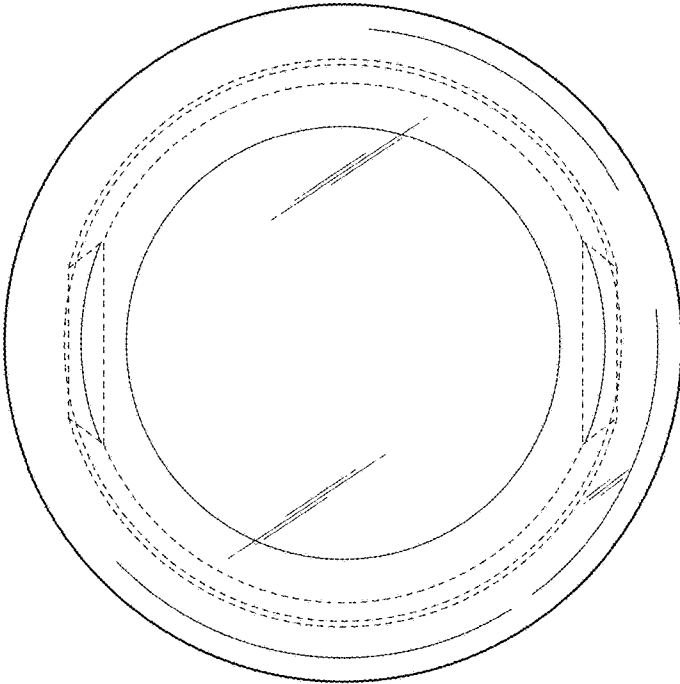
