### BOND FEES

- Customers are responsible for payment of duties and taxes. When funds are not provided in advance by the customer, and UPS must post a bond to allow UPS shipments to be released in advance of payment to the Canada Border Agency (CBSA), a fee of 2.7 per cent (minimum \$5.85 on UPS Standard; minimum \$10.00 on UPS Worldwide Express Plus™, UPS Worldwide Express™, UPS Worldwide Express Saver™ and UPS Worldwide Expedited™) of the amount advanced by UPS will be charged.
- To eliminate Bond Fees, call 1-800-Pick-UPS® (select option 3 for UPS Customs Brokerage) and ask about our Prepayment or Electronic Funds Transfer payment plans.
